September 2, 1982

Anna M. Furman of Benton Hollow Road, Woodbourne, a life-long area resident, died Friday in Narrowsburg after a long illness. She was 78. The daughter of the late George and Lea Bell VanInwegen Burnham, she was born July 21, 1904 in Thompsonville. She was a member of the Concerned Citizens of Hasbrouck and was the widow of Harrison Furman.

The Real Villain of this Allergy Season?

Itchy eyes and a runny nose this time of year is so commonly blamed on those blazing fields of goldenrod. A few years back when Peggy De Wire was with us, she published a column on Goldenrod, it was then that I learned the true culprit of this seasonal allergy.

According to Peggy's notes:

"As Jean and I were enjoying a cup of tea at my kitchen table, she waved her spoon at the vase of bright yellow Goldenrod saying, 'That flower causes hay fever.'"

"Does not," I said. "Goldenrod gets blamed for hay fever because it blooms at the same time as ragweed, the real villain - Goldenrod is insect pollinated; ragweed is wind pollinated."

"Maybe so," Jean replied, holding her cup for a refill. Mmm this tea is good and different. Licorice flavored and pretty yellow in color."

"Jean, we're drinking Sweet Goldenrod tea that I made from the leaves of the bouquet!"

The 'real' villain - Ragweed! Scientists estimate that a single ragweed plant can release one billion grains of pollen over the course of a single ragweed season. And the grains are so light that they float easily even on gentle breezes. Pollen has been detected as far as 400 miles out to sea and up to two miles high in the atmosphere.

If that sounds bad, things may soon get even worse. Recent studies suggest that rising temperatures and carbon dioxide levels are extending ragweed season.

In most parts of the country, the season used to start in mid-August and run through September; now it seems to begin from the first of August through mid-October.

Ragweed is a common perennial herb growing a slender, branching, straw-colored stem to a maximum height near five feet, but more often remaining under thirty-six inches tall. Leaves are up to 4 inches long and vary in shape from lance-shaped to nearly oval, and they are divided into many narrow, pointed lobes. The stem and leaves are hairy.

The top of the stem is occupied by an inflorescence (complete flowerhead of a plant including stems, stalks, bracts, and flowers) which is usually a spike. The species has both male and female reproductive organs; the flowerhead is composed of staminate (male) flower heads with the pistillate heads located below and in the axils of leaves.

The pistillate heads yield fruits which are achenes located within oval-shaped greenish-brown burs about 1/6 of an inch long. The burs are hairy and sometimes spiny. The plant reproduces by seed and by sprouting up from a creeping rhizome-like root system.

Now that we know the truth, maybe we should do what Peggy's friend did.

As she got up to leave, Jean said, 'I think I'll dry some leaves and make my own Sweet Goldenrod tea.' And she sniffed the yellow flowers on her way out."



Fallsburg Town Clerk Donna Akerley Retires

(From Pg. 1) "After 18 years of experience, I figured it would be a good time to give it a try and advance myself with the town, and I was successful," Akerley said.

And Akerley has run successfully and won ever since 2007.

Akerley was born in Mount Vernon, NY and grew up in the Ulster County area but then moved to Sullivan County after meeting her future husband, Eric Akerley.

"I followed my heart and moved up here to Sullivan County to be with him," said Akerley.

Her husband is a retired corrections officer and past fire chief of the Woodridge fire department, her son, Nolan, is a corrections officer and the current fire chief for Woodridge and her daughter, Amie, is an Executive Host at Resorts World Catskills. "I am extremely proud of my family and their accomplishments and have been blessed to have such a strong support system behind my career all these years".

When looking back at her career as a town clerk, she says there are so many fond memories, such as being involved in the community and volunteering with various organizations in Fallsburg, and getting to know so many people has been the most meaningful for her.

"I'm very fortunate to have a wonderful community to live in and work in. I raised my family here and have enjoyed a beautiful life in the Town of Fallsburg said Akerley.

She said over the years and seeing everyone who comes through her office; she has been able to develop lasting friendships and that is really special.

"Just seeing their smiling faces and coming in and chatting with me, sharing their lives and stories with me, it's been very, very rewarding," said Akerley. "I am happy to have been able to connect with so many people and make them feel more comfortable when entering the town hall".

Not only was Akerley the town clerk, but wore many different hats in the Fallsburg government.

She was also the Land Tax Collector, Marriage Officer, Licensing Officer, Permits Officer, Elections Officer, Notary, Past Website Master, FOIL Officer, and Records Management Officer, and Registrar of Vital Statistics for the town.

"All of these titles are very important and hold a great deal of responsibility. Yet, being a marriage officer and actually performing someone's marriage ceremony, Akerley said, "It's one of the most enjoyable parts of the job for me. It's been amazing to share in someone's special day like that, and an honor to even be asked to do something so beautiful". Akerley is the first Town Clerk to ever be appointed marriage officer in the history of the Town of Fallsburg.

Technology has evolved since her time as a Deputy Town Clerk and Town Clerk. Akerley said we used to write all our transactions, deeds, agreements and tax collections by hand on a ledger book. But soon, as time passed, technology had to be upgraded to keep up with the town's demands.

"I always welcome technology because I love learning. I don't feel you can ever stop learning something new,"

said Akerley.

In fact, Akerley said she was part of team that helped transition the town from analog to digital implementing the towns utility billing system.

After Akerley retires on August 31, she said she is looking forward to returning back to the "private sector of her life" and no longer being a public official. "The sheer volume of information and history and responsibility I've had all these years is truly mind boggling". Akerley said. "Tax collection alone has been one of the most intricate parts of the job, having to balance millions of hard-earned taxpayer's dollars perfectly each year is a challenge and is not to be taken lightly".

"I just want to spend more time with my family and have more time to enjoy all the things that make me happy". said Akerley.

However, while she is stepping down from her position, she said she will continue to be part of the community and is not going anywhere and will continue to volunteer her time.

One of the things she is most proud of during her time as town clerk has been the "giving tree." It was a sustainable project brought to her from the girl scouts at the time and Donna has kept it going for many years.

The giving tree is full of items that have been donated and hung outside for those who are less fortunate to come and take a bag of what they need without judgement.

"It was extremely successful, and I will still continue to do the program at a different location added Akerley. She has also used her office as the hub for local food pantry donations which are distributed equally between those locations for over the last 15 years. Donna has also utilized her office getting backpacks filled with school supplies and holiday gifts to children in the community through her partnership with the Boys and Girls Club.

Looking back at her time, she said, "it's been great fun; you try to keep things as friendly as possible yet remain professional and consistent at the same time. A lot of people will come in sometimes, and they don't know what to expect and are a little apprehensive. I've taken great pride in always trying to make people feel comfortable when they come in and let them know they're welcome and can ask whatever they need. And if I can help them, I absolutely would help them. And if I can't, I will absolutely find out how I can." "The words "I don't know" have always been unacceptable to me". Akerley said. "I pride myself on treating the public with a higher standard and wouldn't know how to be anything less than what they deserve".

When Akerley is not working as a town clerk, she loves taking photographs, cooking, and entertaining.

"I love to create, and I can definitely get my creativeness flowing in my kitchen, and I love to share it with my friends and family, and that brings me great pleasure and just being outdoors in nature,"

And Akerley plans in her retirement to spend more time outdoors and travel to places in the country that she has not yet been to. "There is a whole world out there I've yet to discover, and I can't hardly wait to take it all in".

She added, "I appreciate all the kind support from my community over the years, allowing me to remain their town clerk". I'm going to miss seeing their faces on a regular basis from my office. I just hope everyone stays happy and healthy and are kind to one another, our world definitely needs more kindness".

Silver Wings, Iron Cross

Whether you're a fan of history, action-adventure stories or hair-raising thrillers-maybe even all three, as I am-an exciting reading treat is in store for all those who get their hands on a copy of a new WWII thriller entitled, *Silver Wings, Iron Cross*, (Kensington Publishing, \$27.00, 376 pages, ISBN 978-1-4967-3040-5) by Tom Young, whose work is drawing rave reviews from all quarters.

Silver Wings, Iron Cross begins in the late fall of 1944, D-Day has been successfully pulled off in June, and the Allied Armies are fighting their way across Europe. Large parts of France as well as Belgium and the Low Countries have been liberated. From England, the U.S. Eighth Air Force is bombing the industrial heart of Germany during daylight hours, while the British Royal Air Force bombs most every night in a relentless attack aimed at breaking Hitler's ability and will to continue the fight.

Southern England is where US Army Air Force 1st Lieutenant Karl Hagen and his crew are about to take off on their 35th, and final run in a B-17 bomber nicknamed Hellstorm. After the mission is done they'll become members of an exclusive club and be assigned stateside duties back home. Trouble is, the pilot, Karl Hagen, is a second generation German-American . . . and although he hasn't told anyone . . . he has relatives living in Bremen, which is their target for this final mission.

Meanwhile, at sea, Oberleutnant Wilhelm Albrecht, the XO, or executive Officer and second in command of German attack submarine U-351, is doing his best to honor his nation and Kriegsmarine oath by sinking as much Allied Shipping as possible. But, like Karl Hagen, Wilhelm Albrecht is also conflicted. Poorly supplied and badly equipped, the U-boats are being chased down and sunk by Allied sub hunters in the air and on the sea using new technologies that weren't available earlier in the war, when U-boats, hunting in wolf packs were the terror of all Merchant Mariners.

Now, after a long, exhausting sea patrol and with heavy battle damage, U-351 is trying to limp home to the submarine base at Bremen. There, it'll be patched back together as best they can with makeshift repairs, rearmed and sent back on patrol . . . where they're ordered to Sink as many enemy ships as possible, followed by what amounts to a suicide command. The order causes the submarine warrior to desert, as he tries to save his crew from going back out to sea and certain death.

In the skies over the burning city of Bremen, relentless fighter plane and artillery attacks are decimating the air armada. One of the casualties is the Hellstorm, and Karl Hagen is the last man to bailout of the doomed B-17.

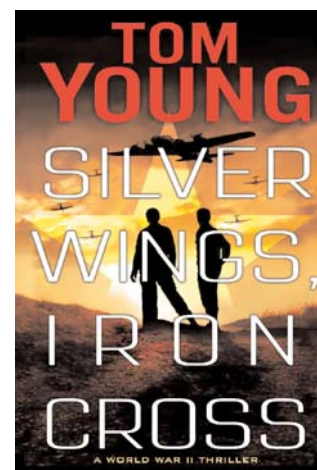
Both men are now alone, on the run and hunted by the authorities. They meet in a chance encounter when both of them take refuge in the same burned out building. Running for their lives, the two young officers are at first hostile and suspicious enemies. Later, they become reluctant allies as life on the run forces them to help each other avoid capture and stay alive. In the end, they forge a deep bond of friendship when an act of courage by one of them saves many lives in the face of certain death in this complex, action-filled and well-written WWII drama that will turn every reader into a fan.

Tom Young has crafted a twisty, kinetic and battle-laden war story that, at the same time, lays open the hearts and minds of the courageous and incredibly young persons who went to war as kids and emerged as the men and women we honor today as The Greatest Generation.

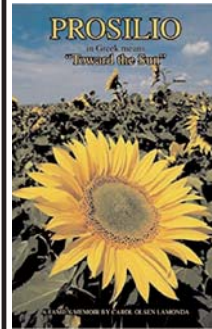

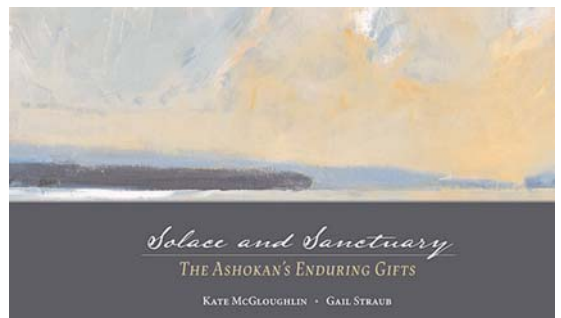

Thanks to science and progress, I am confident that I will not be hospitalized or die.

I hope you will not let your guard down. I truly thought I would escape the scourge of the pandemic or that it would just die out. Be wary, prepared, and test often to protect those around you. If this was a light case, you do not want to do battle with a full-blown case of Covid 19.

DEC Regulations and Restrictions in Effect

Sundown Wild Forest: Peekamoose Blue Hole & Riparian Corridor; Kaaterskill Wild Forest and Indian Head Wilderness

Sundown Wild Forest: Permits are necessary to recreate or camp in the valley from **May 15th - September 15th** each year.

Peekamoose Blue Hole & Riparian Corridor: DEC has issued special regulations for the Blue Hole and Peekamoose Valley because of the huge increase in visitors. The purpose of these regulations is to increase public safety and reduce the impacts to the environmental resource. Visitors are required to obtain a permit for a \$10 fee through Reserve America, consistent with the fees for other recreation-oriented Day Use areas in the Forest Preserve from May 15th-September 15th;

Kaaterskill Wild Forest and Indian Head Wilderness: Town of Hunter has parking restrictions on Route 23A and Platte Clove Road. Park only at designated DEC parking lots. Come prepared with back-up options and move on if the area's parking lot is full. Any illegally parked vehicle will be ticketed and towed to the Town Hall Impound Lot.

UD, DEC and State Parks Battle Wildland Fire in Minnewaska State Park

UC Executive Pat Ryan announces continuing suppression efforts to fight wildfires at Napanoch Point area of Minnewaska State Park, which is currently estimated at 30 acres

ELLENVILLE, N.Y. - Ulster County Executive Pat Ryan announced today continuing suppression efforts to fight wildfires in the Napanoch Point area of Minnewaska State Park through a unified command between New York State Department of Environmental Conservation (DEC) Forest Rangers and staff volunteers, Office of Parks, Recreation and Historic Preservation (OPRHP) staff and Ulster County Department of Emergency Services with support from New York State Police (NYSP) Aviation and the State Division of Homeland Security and Emergency Services (DHSES).

"I want to thank all the agencies, staff and volunteers who have coordinated on the response and assure residents that we are doing everything we can to keep people safe," Ulster County Executive Pat Ryan said. "Conditions right now are very dry, and we must remain vigilant and careful about fires." "We want to assure the local community that we are doing everything we can to keep the fire well within the park and



weather and follow the local regulations," Director of Ulster County Emergency Services Everett Erichsen said. The Napanoch Fire in Ulster County is believed to have been started by a lightning strike on August 27th. Due to remote and rugged terrain, NYSP Aviation was called in to assist with scouting the fire and providing bucket drops. On August 28th, nearly one hundred State and local firefighters, working in a joint unified command led by DEC Forest Rangers, engaged in a suppression effort. Two NYSP helicopters have conducted over a hundred bucket drops.

Assisting on-scene are firefighters from Accord, Kerhonkson, Ellenville, Cragmoor, Napanoch, Walker Valley, Marlboro, Olive, Wallkill, New Paltz Rescue, DEC, OPRHP and Mohonk Preserve. Additional agencies assisting the effort are the Ulster County Sheriff's Office, Ulster County Department of Emergency Services and DHSES.

Over the next 24 hours, the fire is expected to spread and crews will continue to work on suppression efforts. There's one seasonal hunting cabin within the vicinity of the Napanoch Fire, and no immediate threat to residents. If conditions change, notifications will be made. Extremely dry conditions and difficult terrain are increasing the challenges in containing the fire. DEC is working with local fire departments to coordinate a water supply to reach the fire.

To view an up-to-date list of trail closures due to forest fire, visit the Minnewaska State Park Preserve website.

New York's Hudson Valley and Catskill regions remain at high fire danger risk (find the current Fire Danger Map here: <https://www.dec.ny.gov/lands/68329.html>), meaning outdoor fires have the potential to spread quickly, especially if the wind picks up. Fires may become serious and difficult to control unless successfully contained while small. DEC continues to encourage New Yorkers and visitors to follow the recommendations below to reduce the risk of wildfires.

While camping in the backcountry, New Yorkers are advised to:

- Use existing campfire rings where possible;

- Build campfires away from overhanging branches, steep slopes, rotten stumps, logs, dry grass and leaves. Pile extra wood away from the fire;

- Clear the area around the ring of leaves, twigs and other flammable materials; and

- Never leave a campfire unattended. Even a small breeze could cause the fire to spread quickly.

Public Notice: Increased Water Release to Croton River

Dear DEP Access Permit Holder:

In early September, the NYC Department of Environmental Protection (DEP) will begin to draw down water levels in the New Croton Reservoir to allow for routine operational inspections of the New Croton Dam and spillway. As DEP begins lowering the water level of the reservoir, there will be significant increases in the flow of water into the Croton River. The release from the reservoir will increase from the current 5.5 million gallons a day (MGD) and may be as high as 405 MGD, significantly increasing the flow of the river and requiring additional cautions for recreational activities.

Members of the public should be extra cautious while the increased water is released into the river. Activities such as wade fishing and kayaking are discouraged, as the fluctuating flow in the river could make them unsafe. DEP will initiate the increased release starting on or about September 6th and continuing until approximately September 27th.

To ensure public safety, DEP has shared this information with local government officials and public safety organizations. We've also shared this information directly with the public through social media and messages like this one. DEP will also post signs at parks, beaches, boat launch sites, and other points of public access along the Croton River before the increased releases begin. We hope you will share this information with others who recreate along the Croton River downstream of the dam. 9/1

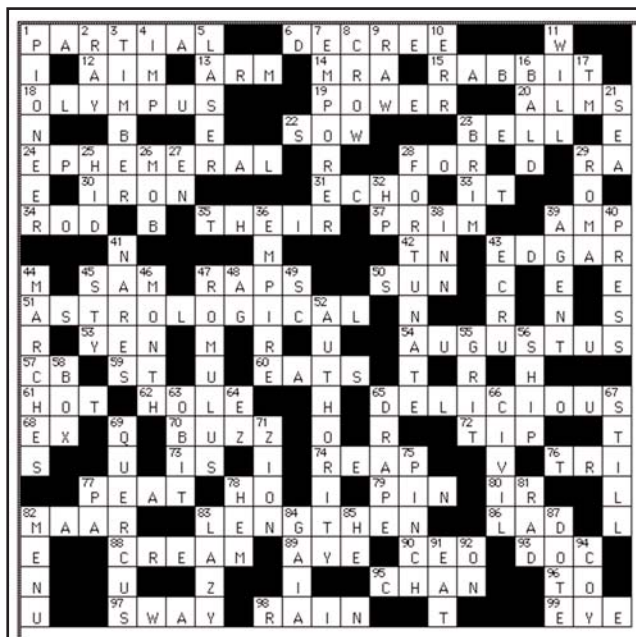

ELLENVILLE, N.Y. - Ulster County Executive Pat Ryan announced this evening that crews are continuing the battle to put out the Napanoch Point Fire in Minnewaska State Park Preserve and working on containment. The Napanoch Point Fire has increased in size due to vegetation, terrain and weather conditions. A new fire, the Stony Kill Fire at Minnewaska State Park Preserve has developed, which crews are responding to, assessing and working to contain.

All access points to Minnewaska State Park Preserve, including the Sam's Point Area, will be closed Tuesday, August 30th, until further notice, to maintain public safety. Anyone with reservations for Saturday, Sunday or Monday over the upcoming Labor Day holiday weekend will be notified and refunded. All visitors must adhere to these closures.

Over the next 24 hours, the response team will be committing an additional 60 firefighters to the operation, and doubling resources to four helicopters for airdrops and 24 all-terrain vehicles. There will be firefighting activities on Berne Road from Port Bend to Ellenville, working on installing a contingency line. Expect to visually see smoke coming off the fires on the mountain.

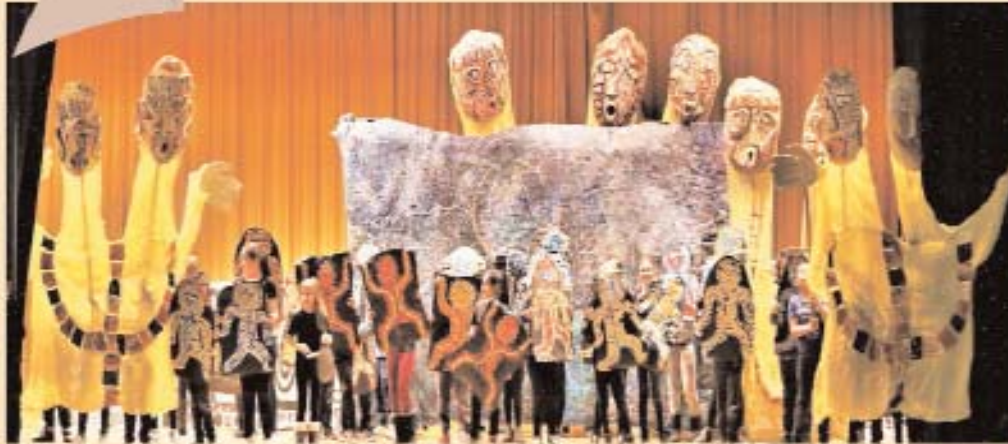

Grahamsville First Aid Squad EMT'S Kept Active During The Neversink Agricultural Society's 142nd Annual Little World's Fair August 19-21, 2022

The Neversink Agricultural Society 142nd Annual Little World's Fair held across the covered bridge across the barely flowing Chestnut Creek with the Grahamsville Fairgrounds was very similar weather-wise to the memorable Wild Woodstock Festival held in Bethel, NY 30 miles away, held in 1969, this exact same weekend 53 years ago.

I could not attend Woodstock that weekend, because I had to enter my mother Becky's multiple exhibits in the Arts and Crafts barn at the Grahamsville Fair. Becky won 3 blue ribbons and 2 red ribbons which to this day are hanging in her barn museum alongside her numerous other ribbons - a forgotten little known historical fact.

The weather at the 1969 3-day festival was unbearably humid and hot with heavy rain showers each evening. The television and movies showed hippies skinny dipping in private ponds and belly-whopping through mudslides.

The weather at the 2022 Grahamsville Little World's Fair was similar this year. From Friday, August 19th, the 4-H and Cornell Cooperative Youth Fair where Future Farmers of America displayed and exhibited their prize cows, horses, goats, sheep, chickens, rabbits, pheasants and quail (but unfortunately no ducks this year) - (though one fellow displayed his live owls on the midway) was hot and humid, with an evening storm. We really needed the water for our streams and reservoirs.

And, Saturday and Sunday, the main days of the Fair, with a huge crowd of participants, seniors, children with parents, attracted by excellent and continuous entertainment (bands "Far Beyond Gone", "Shane Rennison" in the Beer Garden, and "The Other Band" and "Hillbilly Parade", "Jesse Noren" and "Aerestov's Arobatic Extravaganza" all on the main stage) plus the traditional draft horse pull, open horse, swine, youth poultry, egg judging, goat, rabbit, alpaca, Lumberjack Show, Watermelon Eating Contest, Horseshoe Tournament, Classic Car Show, and the 4-H Ag Auction, not to mention the "Wee-Wee-Wee Racing Pig Show" and the Saturday Night Spectacular Fireworks Display. Both days were equally hot and humid with sudden evening thunder and rain squalls. The local Neversink townsfolk and committees, the volunteer Grahamsville, Neversink and Claryville Fire Departments, and the Grahamsville and Neversink First Aid Squads and Emergency Medical Technicians were all forewarned and, as best they could, carefully prepared.

The Grahamsville First Aid Squad had Eight Calls on the Saturday of the Fair

On Friday, the opening day of the Youth Fair and Judging, the Grahamsville First Aid Squad had a large white tent set up at the start of the Main Fairway (which led up to the livestock, poultry and small animal at the top). A few tents above them were the American Red Cross.

According to the members, there were at least 18 First Aiders and Emergency Medical Technicians in varied shifts throughout the three-day fair. This included several EMT's from other rescue squads (some from as far away as Cooperstown) who were visit-

ing the fair, stopped by to say hello to fellow EMT's and offered their assistance and services on these hot humid days. Their assistance was appreciated and needed.

The First Aid members were kept busy, having exhausted visitors lying down

on cots, taking blood pressure and giving out water.

But this year, this fair was perhaps the busiest. On Saturday, there were 8 major calls involving the "GATOR" - a four-wheel,



engine driven go-cart with a special bed on the rear to carry out patients on stretchers from all areas of the Fairgrounds (from the livestock display on top, to the stage area and the wood cutting area by the end of the western fairway under the large Arts and Crafts sales tables in the open barn area.



It was usually quite a scene when the First Aid Gator was in action transporting. There would be lights flashing and several people on each side moving the on-goers aside, followed by another four-wheeler. The smoothest transport path to the Fairway was between the Grahamsville Fire Department Sweet and Hot Sausage Booth (with its long lines) and the Tri-Valley Lions Soda Booth, then down the fairway between the funnel cakes and the watermelon booths.

The Gator would slowly go down the Fairway to the Grahamsville First Aid Squad Tent with an ambulance waiting to take vitals and determine the next course of medical action. The "Gator" was a blessing this year at the fair.

With the heat and humidity, many concessions ran out of water and soda early.

There was no volunteer schedule. Whenever a First Aider came around, they stayed. There was plenty of work this weekend.

I asked the First Aider Chief Ambulance Engineer Alex when they got the "Gator". He said that the "Gator" is owned by the neighboring Rock Hill Fire Department.

By reciprocal arrangement, for the past 5 years, Rock Hill graciously and generously lent us the "Gator" for the Grahamsville Fair, and other big related large events. The Sullivan County Fire Departments are very close and cooperative.

I asked Alex if Grahamsville should buy a "Gator" for its own use. He replied, annoyed, that it would be an unnecessary waste of our community money under the circumstances.

That is why, Grahamsville, the Town of Neversink and Sullivan County is such a beautiful community.

Sullivan County Working Closely with State Regarding Polio Response

No Local Cases, But Public Health Urges Vaccination Following Identification of Poliovirus in Wastewater Samples

Liberty, NY - Sullivan County's Department of Public Health is working closely with the New York State Department of Health (NYSDOH) in response to the detection of poliovirus in wastewater samples within the County's borders.

"We've been preparing for this possibility for weeks because of the wastewater surveillance results for poliovirus in Rockland, Orange and NYC, and previously secured additional polio vaccine for area healthcare providers and the County health department," Public Health Director Nancy McGraw explained. "I want to be clear, however, that to date we have not had any cases of polio found in Sullivan County, and so long as all adults and children are vaccinated, the disease poses no threat."

"The public should also be assured that there is no danger of contracting polio from drinking water," McGraw added. "Typical transmission is via the oral-fecal route (touching fecal matter, then touching the mouth or face), and is of concern only to those who have not been vaccinated or for children who are behind in their immunizations. Providers should take time in every primary care visit with adults and children to ensure that they are up to date with the recommended vaccines for their age."

"Sullivan County is taking all reasonable steps to monitor the situation and keep the people of the County safe," noted County Manager Josh Potossek. "We urge parents and adults to be vigilant and aware of their vaccination status, because polio is a disease that can be eliminated through vaccination."

What is polio?

Polio is very contagious to the unvaccinated, and a person can spread the virus even if they aren't sick or experiencing symptoms. The best way to keep adults and children polio-free is through safe, on-time childhood immunizations, and adult immunization for polio when someone has not been previously vaccinated.

The polio virus enters the body through the mouth, usually from hands contaminated with the stool of an infected person. Respiratory and oral-to-oral transmission through saliva may also occur. Symptoms, which can be mild and flu-like (fatigue, fever, headache, stiffness, muscle pain, vomiting), can take up to 30 days to appear, during which time an infected individual can be shedding virus to others.

"Sullivan County has an overall 62.33% vaccination rate for polio, but there are some areas of the County with lower vaccination rates, and because polio can spread very easily, it's important that everyone is vaccinated," explains McGraw. "Public Health is offering a safe and proven vaccine available to children two months of age or older. We are working with the State to get vaccine to providers for adults. If adults need vaccine, we encourage them to contact their healthcare provider."

What are the symptoms of polio?

Polio is highly infectious. Symptoms range from nothing to mild and flu-like to serious, including paralysis, permanent disability or post-polio syndrome, even death.

Paralysis is the most severe symptom associated with polio, because it can lead to permanent disability and death. Even children who seem to fully recover can develop new muscle pain, weakness, or paralysis as adults 15 to 40 years later. This is called post-polio syndrome.

How can I protect myself against polio?

The best way to stay polio-free is to maintain high immunity across the population through vaccination. If you received the vaccine already (for example, as a child when attending public school), you are considered protected for life. No booster shot is necessary, unless travelling to an area where there is high transmission.

Most adults do not need polio vaccine because they were already vaccinated as children. New Yorkers who are not up-to-date with vaccination should speak to their health care provider or their child's provider to schedule an appointment for vaccination against polio and other dangerous diseases, such as measles, mumps, whooping cough, chickenpox and COVID-19.

Polio outbreaks are happening globally. Children and adults should be up-to-date with polio and other routine immunizations before travelling. Adults who received polio vaccine as children should receive a one-time lifetime booster if travelling to an area where there is a poliovirus transmission.

Sullivan County's vaccination rate for polio is 62.33%, compared to 60.34% in Rockland and 58.68% in Orange counties. The statewide rate is 78.96%.

If you or your child are not yet vaccinated, now is the time to get vaccinated.

Urging Immunization and Warning of Expanding Community Spread, State Department of Health Updates New Yorkers On Polio In New York State

Poliovirus Now Detected in Four Wastewater Samples Collected in July and August in Sullivan County, Linked to Paralytic Polio Case Previously Identified in an Unvaccinated Individual in Rockland County
Wastewater Samples in Rockland County, Orange County, and New York City Had Already Provided Additional Evidence of Local Transmission and Circulating Polio That Can Cause Paralysis

Adults and Children Urged to Get Immunized and Stay Up to Date with Polio Immunizations
 Albany, N.Y. (August 26, 2022) - Urging immunization and warning of expanding community spread, the New York State Department of Health (NYSDOH) today updated New Yorkers on poliovirus in New York State. Sequencing analysis performed by CDC has now detected poliovirus in four samples from Sullivan County, two collected in July and two collected in August, which are genetically-linked to the case of paralytic polio previously identified in Rockland County. Already, poliovirus had been identified in samples collected in Rockland County, Orange County, and New York City. All samples reported are samples of concern, meaning they are types of poliovirus that can cause paralysis in humans.

"One New Yorker paralyzed by polio is already too many, and I do not want to see another paralytic case," State Health Commissioner Dr. Mary T. Bassett said. "The polio in New York today is an imminent threat to all adults and children who are unvaccinated or not up to date with their polio immunizations. Every New Yorker, parent, guardian, and pediatrician must do everything possible to ensure they, their children, and their patients are protected against this dangerous, debilitating disease through safe and effective vaccination."

To protect adults and children against paralytic disease, every adult and child must get immunized against polio and stay up to date with polio immunizations.

All New Yorkers who are unvaccinated, including children by 2 months of age, those who are pregnant, and people who have not completed their polio vaccine series previously, should get immunized right away. Unvaccinated New Yorkers or those not up to date with vaccinations who live, work, go to school in, or visit Rockland County, Orange County, New York City, and Sullivan County are at the highest risk of contracting paralytic disease. While there is no cure for polio, it is preventable through safe and effective immunization.

Nancy McGraw, MPH, Public Health Director of Sullivan County Department of Public Health said: "There is no cure for polio, but it can be prevented with safe and effective vaccination which has been available for a very long time in the U.S. to eliminate the disease. Polio is among the top preventable diseases, and we have the ability to stop this in its tracks as long as people take the importance of immunizations seriously."

Joshua A. Potosek, Sullivan County Manager said: "Sullivan County is taking all reasonable steps to monitor the situation and keep the people of the County safe. We urge parents and adults to be vigilant and aware of their vaccination status, because polio is a disease that can be eliminated through vaccination."

Following the identification of a case of paralytic polio among an unvaccinated individual in Rockland County, NYSDOH, in partnership with local health authorities and the Centers for Disease Control and Prevention (CDC), launched wastewater surveillance, a tool to check for signs of the virus in sewage water in Rockland County and the surrounding areas.

NYSDOH continues to conduct case investigation, aggressively assess spread, and ensure prevention measures, particularly vaccine and immunization clinics, are in place - as the best way to keep New Yorkers polio-free is to maintain high immunity across the population through vaccination. The inactivated polio vaccine (IPV), the only vaccine available in the United States, is at least 99 percent effective at preventing disease among people who get all the recommended doses. (Contd. Urging Immunization and Warning of Expanding Community Spread, State Department of Health Updates New Yorkers On Polio in NYS

(From Pg. 33) Individuals infected with polio shed virus in their stool. Wastewater samples are based on water from our sewage system, which collects and treats feces flushed down the toilet. Health officials use this surveillance for evidence of where and when the virus is spreading in communities, though it does not provide quantitative information about who or how many people or households may be infected. New Yorkers should know that wastewater collected in sewer systems cannot be a source of infection or transmission for the general public, and it does not contaminate drinking or tap water.

Polio is a serious and life-threatening disease. Spread from person-to-person, polio is very contagious, and an individual can transmit the virus even if they aren't sick. Asymptomatic spread is a high concern among health officials, particularly following the identification of a paralytic, symptomatic polio case. Based on evidence from earlier polio outbreaks, health officials estimate that for every one case of paralytic polio observed, there may be hundreds of other people infected.

Polio is very contagious, and a person can spread the virus even if they aren't sick or experiencing symptoms. The polio virus enters the body through the mouth, usually from hands contaminated with the stool of an infected person. Respiratory and oral-to-oral transmission through saliva may also occur. In addition to immunization to prevent disease, New Yorkers should know that handwashing with soap is important, as alcohol-based sanitizers do not work on some types of germs, like polio.

According to CDC, 70 percent of people infected with polio experience no symptoms, and 25 percent experience mild or flu-like symptoms that may be mistaken for many other illnesses. About 1 in 100 individuals will develop severe disease, including permanent paralysis. Of those paralyzed, 2-10 percent die when their breathing muscles become immobilized.

NYSDOH has increased communication to healthcare providers, stressing the importance of testing and the on-time administration of the polio vaccine among their patients. In accordance with CDC:

- o All children should get four doses of the polio vaccine, with the first dose given at 6 weeks through 2 months of age, followed by one dose given at 4 months of age, 6 through 18 months old, and 4 through 6 years old.

- o People who are unvaccinated or are unsure if they have been immunized should receive a total of 3 doses, if they are starting the vaccine series after age 4.

- o Adults who have only had 1 or 2 doses of the polio vaccine in the past should get the remaining 1 or 2 doses - it does not matter how long it has been since the earlier doses.

A core component of CDC's

childhood immunization schedule and required by NYSDOH for all school-aged children, most children are already vaccinated. New Yorkers who are unsure of their or their child's vaccination status should reach out to a healthcare provider right away. As of August 1, 2022, Rockland County has a polio vaccination rate of 60.34 percent, Orange County has a polio vaccination rate of 58.68 percent, and Sullivan County has a polio vaccination rate of 62.33 percent, compared to the statewide average of 78.96 percent, among children who have received 3 polio immunizations before their second birthday.* A rate of well over 90 percent is NYSDOH's goal. NYSDOH has also engaged community-based organizations in the affected areas to partner on outreach, disseminating education about the virus, the safe, protective nature of the well-established immunization, and the gravity of the current situation.

About New York State Polio Vaccination Rates

*Based on data calculated from August 1, 2022 from the New York State Immunization Information System (NYSIIS), polio vaccination rates include all New York counties, with the exception of New York City. The rate is calculated based on data of children who have received 3 polio immunizations before their second birthday, reported their residency as the State of New York, provided their New York State county of residence, and have at least one immunization or have an upstate New York State birth record. As of January 8, 2008, all healthcare providers in New York State are required to report all immunizations administered to people less than 19 years of age, along with the person's immunization histories, to NYSDOH using NYSIIS. New York City maintains their own non-COVID-19 immunization records through the Citywide Immunization Registry (CIR).

Classes are for Town of Neversink and Tri-Valley School District residents who are 18 or older.

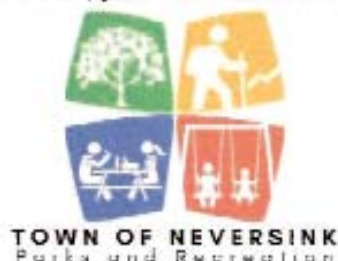

Statement from UC Executive Pat Ryan and Comptroller March S. Gallagher on Finance Department's Transaction Error

"During my tenure as County Executive, Ulster County has consistently been recognized for its strong financial stewardship - earning a AA bond rating from S&P and being named one of the most fiscally sound counties by the New York State Comptroller's Office, all while consistently keeping taxes flat and increasing vital services. In 2020, our team proactively identified an erroneous wire transfer to the NYS Department of Taxation and Finance as a duplicate payment of approximately \$1 million in spring 2020, which was identified by the Finance Department within days. This issue was swiftly resolved, money was returned with interest, and there was no harm to Ulster County taxpayers. I want to thank the Ulster County Comptroller's office for verifying the error was quickly corrected and there was no loss to the taxpayers, and I am fully confident in the findings," Ulster County Executive Pat Ryan said.

"The Comptroller's Office and Executive's Office separately reviewed the transactions associated with the allegation and the related documentation and reached the same conclusion. We have determined that there was an overpayment of taxes to the State of New York, that when identified was rectified, and eventually refunded to the County with interest. There was no financial loss to the taxpayers because of the error," Ulster County Comptroller March Gallagher said.

New York-Led Multi-Agency Consortium Now Includes Six States and More Than 60 Hydrogen Ecosystem Partner

• Partners to Develop Proposal for Federal Infrastructure Investment and Jobs Act Funding, Expected to be Released in September/October with up to \$8 Billion in Total Funding Available

• Supports Climate Leadership and Community Protection Act Goal to Reduce Greenhouse Gas Emissions 85 Percent by 2050

Governor Kathy Hochul today announced Maine and Rhode Island have signed on to a New York-led multi-state agreement, joining with Connecticut, Massachusetts and New Jersey to develop a proposal to become one of at least four regional clean hydrogen hubs designated through the federal Regional Clean Hydrogen Hubs program included in the bipartisan Infrastructure Investment and Jobs Act. The coalition of six states and now more than 60 clean hydrogen ecosystem partners are laying the groundwork for a proposal for the United States Department of Energy funding opportunity anticipated to be announced in September or October with up to \$8 billion in total funding available. Today's announcement advances each State's leadership in clean hydrogen infrastructure deployment and supports New York's Climate Leadership and Community Protection Act goal to reduce greenhouse gas emissions 85 percent by 2050.

"New York is pleased to welcome Maine and Rhode Island to this diverse and dynamic group of partners as we continue our work to develop and implement a vision for a regional clean hydrogen hub that advances our shared climate goals," Governor Hochul said. "Building a robust and connected clean hydrogen market across the northeast will provide a game-changing clean energy alternative that will transform our ability to meet our shared climate goals while advancing 21st century innovation and stimulating strong economic growth throughout the region."

Since the initial announcement in March, New York has continued to add strategic partners that now include 14 private sector industry leaders, 12 utilities, 20 hydrogen technology original equipment manufacturers (OEMs), 10 universities, seven non-profits, five other states, two transportation companies and three state agencies. New York will continue to engage with states and entities who are interested in joining, so as to further solidify the region as a viable clean hydrogen hub.

Consortium partners have committed to collaborate with the New York State Energy Research and Development Authority (NYSERDA), New York Power Authority (NYPA), and Empire State Development (ESD) on proposal development to advance clean hydrogen projects. Partnering states will also coordinate with their respective state entities to help align the consortium's efforts with each state's climate and clean energy goals. These include Connecticut's Global Warming Solutions Act goal of reducing greenhouse gas emissions 80 percent by 2050, Massachusetts' goal of reaching net-zero carbon emissions by 2050, New Jersey's Global Warming Response Act goal of reducing greenhouse gas emissions 80 percent by 2050, Maine's statutory goals to achieve carbon neutrality by 2045 and reduce gross greenhouse gas emissions by at least 80 percent by 2050 and Rhode Island's commitment to achieving 100 percent renewable electricity by 2033.

The New York Climate Action Council Draft Scoping Plan, released in December 2021, identifies low-carbon fuels such as clean hydrogen as an important component of a strategy to achieve the goals of the Climate Act in sectors that are challenging to electrify, such as transportation and heavy industry.

With the execution of these agreements, the partners will work together to:

- o Define the shared vision and plans for the regional clean hydrogen hub that can advance safe clean hydrogen energy innovation and investment to address climate change, while improving the health, resiliency, and economic development of the region's residents.
- o Advance a Hub proposal that makes climate and environmental justice central to its strategy, which will deliver opportunities and improved quality of life to under resourced areas across the region.
- o Perform research and analysis necessary to support the hub proposal and align on approach to quantifying greenhouse gas emissions reductions as a result of deploying this technology.
- o Develop a framework to ensure the ecosystem for innovation, production, infrastructure, and related workforce development is shared across all partner states.
- o Support environmentally responsible opportunities to develop clean hydrogen, in accordance with participating states' policies.

The coalition will continue to focus on the integration of renewables - such as onshore and offshore wind, hydropower, and solar PV - and nuclear power into clean hydrogen production, and the evaluation of clean hydrogen for use in transportation, including for medium and heavy-duty vehicles, heavy industry, and power generation applications or other appropriate uses consistent with decarbonization efforts.

In June 2022, the United States Department of Energy (DOE) announced that an initial Clean Hydrogen Hubs Funding Opportunity Announcement (FOA) would be issued in September or October 2022 with an anticipated \$6-7 billion in funding available. This initial funding is anticipated to support 6-10 clean hydrogen hubs and be awarded some time in 2023; another \$1-2 billion may be made available for future FOA launches or other supporting activities. Proposals may be awarded up to a maximum of \$1.25 billion.

SUNY and CUNY Will Each Receive \$2 Million To Support Students Underrepresented in Mental Health Degree Programs

Partnership with State Office of Mental Health Aimed at Attracting, Retaining and Graduating Minority and Multilingual Students

Governor Kathy Hochul today announced \$4 million in federal funding to support underrepresented students entering or enrolled in mental health degree programs at State University of New York or City University of New York campuses. Through a partnership with the New York State Office of Mental Health, SUNY and CUNY will each be provided \$2 million to support tuition assistance, paid internships, and direct stipends for minority and multilingual students.

"As we continue to strengthen our health care system in New York, we must ensure that we build a diverse and inclusive workforce," Governor Hochul said. "This partnership will provide incentives for underrepresented students to enroll or remain in

mental health programs - helping diversify our future workforce and ensure that all communities are well-served by our public health care system."

The partnership will incentivize minority and multilingual students enrolled at 18 CUNY campuses - including five community colleges, eight senior colleges, three comprehensive colleges and the CUNY Graduate Center and CUNY School of Professional Studies - and 16 SUNY campuses - including eight community colleges, four comprehensive colleges, and four university centers - to enter in or continue paths of study that will prepare them for the mental health field. This is the latest action New York State has taken to address a lack of diversity in the field, which in turn leads to disparities in the delivery of mental health care for marginalized populations.

Minority health care providers are more likely to meet the needs of underserved populations, with a diverse workforce resulting in greater patient and client satisfaction, engagement, and retention in care. Additionally, the mental health workforce is experiencing a shortage of multilingual clinicians, further driving disparities in access, quality, and treatment outcomes for individuals who have limited English proficiency.

Students eligible for this assistance are those who are multilingual; enrolled in a language-specific degree program; or are of Cuban, Mexican, Puerto Rican, Hispanic, Latinx, Spanish origin, or are Native American, Alaska Native, Black, African American, Native Hawaiian or other Pacific Islander.

Eligible programs at CUNY include certificate, associate, bachelor's, master's and doctorate programs in social work and human services; psychology; psychiatric nursing; and grief counseling and mental health counseling.

At SUNY community colleges, eligible programs include associate degree programs in liberal arts and sciences: humanities and social sciences with tracks or concentrations including mental health assistant, human services, sociology, and psychology. On four-year SUNY campuses, eligible degree programs include health and society; public health concentration; sociology and psychology.

Many of these four-year institutions also offer a Master of Science degree program in mental health counseling and a master's degree program in social work, as well as dual degree programs in mental health counseling or a master's degree in public health. Eligible studies at SUNY university centers include Bachelor of Science degrees in mental health counseling, human development; and doctorate degrees in sociology, psychology; and Doctor of Psychology degrees.

Federal legislation made the initiative possible by providing New York State with supplemental funding for mental health services through a time-limited expansion of the Federal Medical Assistance Percentage, the formula used to reimburse states for most Medicaid programs.

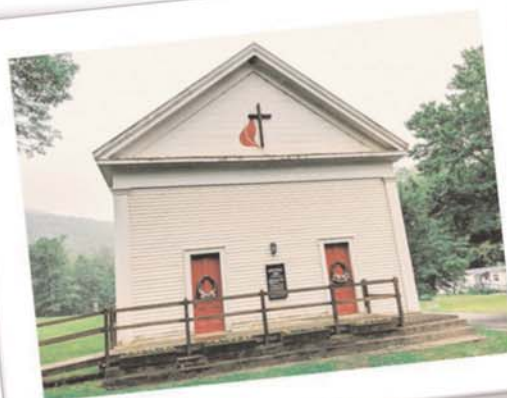

Levi said, "New York State's network of Birding Trails offers great opportunities for families to get outside and explore our unparalleled natural settings and wildlife. Our picturesque birding trails complement any weekend getaway or extended vacation, and the new trails will encourage residents and visitors alike to plan a trip and come be a part of all the outdoor fun in New York State."

Covering five counties, the Catskills segment includes 23 locations on public lands in Delaware, Greene, Schoharie, Sullivan, and Ulster counties. From Forest Preserve lands and iconic State parks to a national wildlife refuge and the popular Ashokan Rail Trail, visitors can combine birding with other pursuits like hiking and biking. The Catskills Visitor Center is a great place to start a birding adventure in this region.

New segments of the Birding Trail were opened in a phased approach. DEC announced the New York City trail segment in October 2021, Greater Niagara in February 2022, Long Island in March 2022, Hudson Valley in April 2022, and Central-Finger Lakes and the Capital Region in May. With 312 locations, the Statewide Birding Trail provides birding opportunities for everyone, regardless of age, ability, identity, or background, across New York State.

DEC continues to solicit input from a wide range of New Yorkers and organizations that represent Black, Indigenous, and People of Color (BIPOC) communities and is making trail information available in both English and Spanish. Bird walks will be held in collaboration with organizations working with BIPOC communities.

The New York State Birding Trail map is available at www.ibirdny.org and provides valuable information on each site such as location, available amenities, species likely to be seen, directions, and more. Digital information on the Birding Trail will be updated periodically, so budding outdoor enthusiasts are encouraged to check back often.

In addition to State-owned and managed locations for the Birding Trail, publicly and privately managed sites can complete a simple self-nomination process to be considered for inclusion on the trail. Sites all meet criteria to help ensure a positive experience for visitors throughout the state. Additionally, each site will post signage noting it as an official location on the birding trail. For information on the nomination process, see www.ibirdny.org.

DEC encourages birding enthusiasts to visit I Bird NY for more information on where and how to observe birds, upcoming bird walks, a downloadable Beginner's Guide to Birding (PDF) (available in Spanish), additional resources, and information on the recently announced 2022 I Bird NY birding challenges.

DEC manages and oversees nearly five million acres of public lands and conservation easements and plays a vital role in both protecting New York's natural resources and providing opportunities for people to enjoy the outdoors. 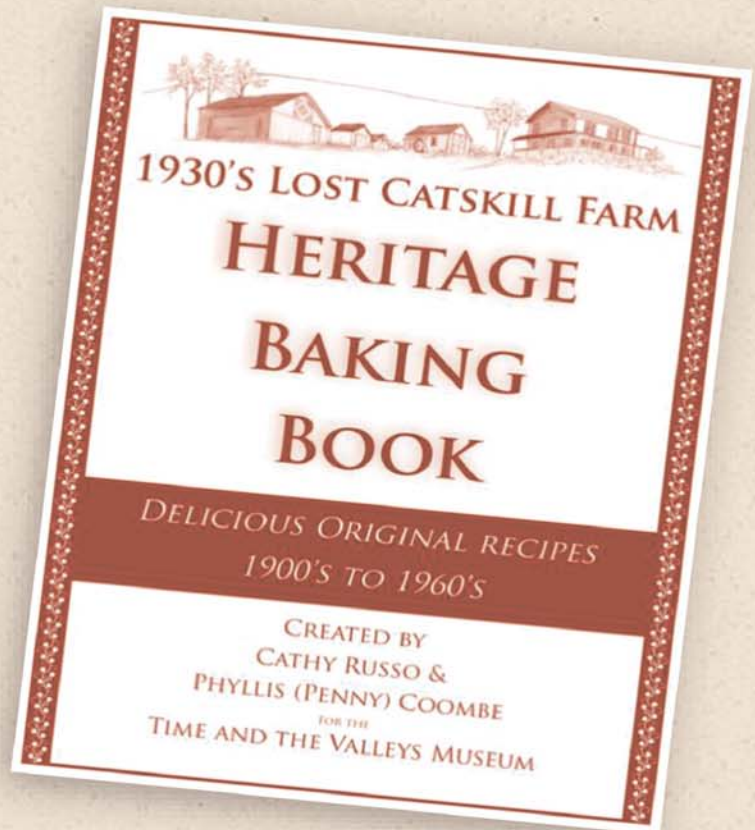

Sullivan County Commits to Moving Forward With SUNY Sullivan Indoor Arena *Facility Will Be Open to the Public and Schools*



Loch Sheldrake, NY - Up to \$20 million may be bonded to make SUNY Sullivan's indoor pool and sports arena a reality, thanks to the Sullivan County Legislature.

"The college is our crown jewel, and we want it to grow brighter in coming years," stated Legislature Chairman Robert A. Doherty. "That's why we've dedicated millions of dollars to not just this project but their annual budget and a crucial, ongoing rehab of their facilities, including a needed upgrade of their heating and ventilation system. We want them to continue being the incredible resource they have long been to the entire County."

"We agreed that this proposal is a great chance not just for our college but for the Town of Fallsburg to really stand out in the crowd. We can bring large sporting events and shows to the arena, and the facility will be available for public rental," pointed out Legislator Joe Perrello, in whose District 7 the college sits. "The Legislature needed to show the State - which is funding half of the project - that we're serious, and I'm grateful my colleagues feel the same way I do about this opportunity."

"SUNY Sullivan has a long and storied history of athletic excellence. This exciting new facility will allow us to offer new sports and expand our current track program," remarked SUNY Sullivan President Jay Quaintance. "Additionally, this state-of-the-art facility will be available to Sullivan County school districts for their athletic needs, will be open to residents to provide much-needed access to year-round fitness opportunities, and will be an anchor athletic facility to drive programming and tourism to Sullivan County. We are very excited to move this project forward."

The aquatic and recreation facility - which is planned to feature a 25-meter-long, 8-lane pool and a 200-meter track oval - is anticipated to cost between \$15 and \$30 million but may not require any bonding, said County Manager Joshua Potossek.

"We'll be working with the college and the State to see if we can accomplish this transformative project without borrowing funds," he explained. "The \$20 million bonding resolution legislators passed on August 18 simply gives us the ability to borrow up to that amount if needed."

The County will soon issue a request for proposals for conceptual renderings.

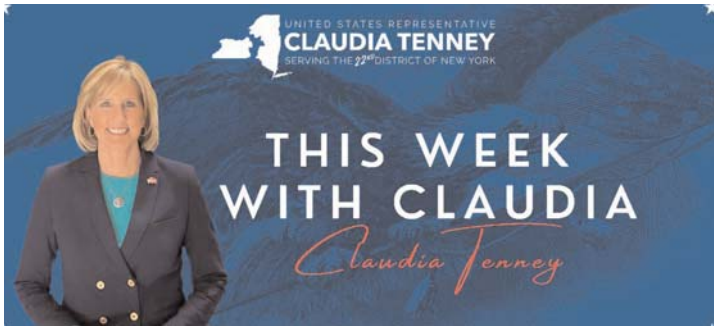

Congresswoman Tenney's Statement on President Biden's Student Debt "Cancellation" Plan

UTICA, NY -- Congresswoman Claudia Tenney (NY-22) today released the following statement following the announcement of President Biden's plans to "cancel" federal student loan debt for individuals making less than \$125,000, or married couples making less than \$250,000, per year.

DEC Forest Rangers - Week in Review Recent Statewide Forest Ranger Actions

New York State Department of Environmental Conservation (DEC) Forest Rangers respond to search and rescue incidents statewide. Working with other state agencies, local emergency response organizations, and volunteer search and rescue groups, Forest Rangers locate and extract lost, injured, or distressed people from across New York State.

Town of Ramapo Rockland County

Wildland Fire: On Aug. 15 at 6:40 p.m., Forest Rangers and members of the New York State Office of Parks, Recreation and Historic Preservation responded to the Wanoksink Fire in Harriman State Park. By 11 p.m., the fire had spread to 12 acres. Rangers started burning a control line to keep the fire contained to a 34-acre area. By Aug. 17, the fire was put into patrol status. Drone video of the fire is available for download at DEC's website. The fire is believed to have started as an unattended campfire. DEC continues to urge New Yorkers to practice the utmost safety when building campfires this summer.

Town of Shandaken Ulster County

Wilderness Enforcement: On Aug. 20 at 8 a.m., Forest Ranger Franceschina received several photos of a couple camped on the summit of Wittenberg Mountain. Rangers Franceschina and Martin responded, but by the time they reached the summit at approximately 11:30 a.m., the subjects had left the area. Rangers continued their foot patrol, checking neighboring peaks and the Terrace Mountain lean-to. Rangers spoke to passing hikers and determined the illegal campers were on their way back to the trailhead. At 4 p.m., Rangers found the pair and issued tickets for camping above 3,500 feet and having a fire above 3,500 feet in the Catskill Park.

Between March 22 and Dec. 20, camping is prohibited above an elevation of 3,500 feet in the Catskills, except in an emergency. Fires are prohibited above 4,000 feet in the Adirondacks and 3,500 feet in the Catskills, except in an emergency.

Town of Wawarsing Ulster County

Wildland Fire: On Aug. 21 at 4:30 p.m., Forest Rangers responded to the Losees Hill Fire behind Laurel Mountain Road in Wawarsing. Rangers worked on bulldozer lines to contain the fire to 2.5 acres. Rangers were assisted by multiple volunteer fire departments and the New York State Office of Parks, Recreation and Historic Preservation. By 10:40 p.m., the fire was 75 percent contained. Drone video of the fire is available for download at DEC's website.

Dry weather throughout the summer has increased the risk of fires. More information about how to reduce the risk of wildfires can be found at DEC's website.

Be sure to properly prepare and plan before entering the backcountry. Visit DEC's Hike Smart NY, Adirondack Backcountry Information, and Catskill Backcountry Information webpages for more information.

If a person needs a Forest Ranger, whether it's for a search and rescue, to report a wildfire, or to report illegal activity on state lands and easements, they should call 833-NYS-RANGERS. If a person needs urgent assistance, they can call 911. To contact a Forest Ranger for information about a specific location, the DEC website has phone numbers for every Ranger listed by region.
